

The objectives of this MoU shall be

Both the parties shall promote the exchange of technical expertise including faculty support, resource persons, joint field level research projects including academic and action research, guest lectures, support though the students and interaction on issues relating to best practices/ Innovations


3. Sharing Infrastructure Facilities


As and when required, both the parties shall share their infrastructure including accommodation and other conference hall facilities, on mutually agreed terms, free of cost or with proper discount for the conduct the programs under this MoU.

The first party shall

1. The MES Asmabi shall take lead action, develop draft proposals to have joint efforts to fulfil the above said objectives.
2. On obtaining the response form the second party the program shall be added to this MoU as annexures after obtaining permission form the governing council
2. MES Asmabi College shall share all the necessary infrastructure including classroom facilities, computers, electrical power, etc. to the possible extent.
3. Shall regularly record and report the progress to the second party and to the governing council based on mutually agreed terms

The second party shall

5. The Second party shall arrange to provide expertclasses, practical classes as well as Industrial visits and training in their projects to equip the students with latest Industrial skills.
6. The second party shall arrange field visits, client interactions etc.
7. The second party will arrange qualified and competentpersonals to conduct the classes to the best of satisfaction of the first party.
8. The second party shall arrange industrial visits for the students on request. Expenses including Conveyance shall be decided based on desired

Governance, Monitoring and Evaluation

9. Both the parties shall form a governing council consisting of three members from the first party and two members form the second party including the two representees of these agreement.
10. The duty of the governing council shall be i. decision making on each initiatives or programs, ii. recognitions of each program and adding to this MoU as annexures, iii. Monitoring and evaluation of activities, iv. resolving of disputes if necessary, and all these shall be on mutually agreed terms.

BUDGET / FINANCES

11. Budget for specific activities will be prepared jointly by the parties and will be part of this MoU as annexure.
Duration

12. This agreement will be in force from 15th NOVEMBER 2021 to 1st JUNE 2026 or end of the academic year 2026-27 on mutual decision.

13. The duration of this MOU will be for five years from the academic year 2021-22 to 2026-27.

TERMINATION

14. Any of the Parties can terminate this MoU on mutually agreed terms and conditions by serving a written notice on the other party 3 months prior to the intended date of termination.

DISPUTES

15. Any disputes shall be communicated in writing or email to each other and to the Governing Council and shall be decided upon mutually agreed terms within a period of one month on receiving the notice/communication.

16. This agreement shall be governed by the Law of India subject to the jurisdiction of Courts in Kerala.

17. This MoU and its annexures constitute the entire agreement among the Parties' and supersede all other representations, understanding or communication whether written or verbal, with respect to the subject matter hereof.
