
A meeting of the staff council was held at the principals chamber on 19th October at 3.30 pm. The principal welcomed the members of the staff council and initiated the discussion. Then he read out the report of the enquiry commission



joined to investigate the matter regarding the complaint lodged by Dr K Kesavan and the faculty members of the department of Fish Processing Technology against a few students on their disrespectful behaviour. It was resolved that the students who were suspended should give explanation in the next staff Council meeting on October 26<sup>th</sup>. He mentioned that all the matter discussed in the meeting should be kept among the members of the meeting. Afterwards he read the complaints lodged by a few students to the University against the College. All the members of the staff Council unanimously agreed that the complaints are baseless. It was mentioned in the letter that the first strike in the college was held on August 26<sup>th</sup> 2023 to improve few amenities in the college and hostel. In fact August 26<sup>th</sup> was a holiday during the Diwali vacation. Further conducting a strike in a college where campus politics and strikes are banned are against the court order. Dr K Kesavan pointed out the aforementioned points. In the letter it was written that Dr K Kesavan and Sri Mohammed Azeem used physical force to deal with the students which is a matter far removed from reality. It was said that there are video clips in which the students pushed the above mentioned teachers. Dr K Kesavan was entrusted the duty to draft replies to the two letters. Afterwards the principal talked about the case filed by Ms Shehnaaz of III BA English in the high court. As she obtained only 72% attendance during the fifth semester



She got condonation and was not eligible to contest in the college election. The days in which she claimed attendance in the court were the days she was present in the college and those days were included in the 72% attendance. When the court demanded to show the attendance register it was provided. The principal reminded that all the departments should maintain proper attendance register and that the monthly attendance should be published in the notice board regularly. It was decided that students of Commerce and English can participate in the Seminar on 'Palestine War and Israeli Invasion' on Friday, 20<sup>th</sup> October jointly organised by the College and Mes Thiruvur District Committee. He asserted that the teachers of the respective classes should accompany the students and all should participate in the seminar until the end. Other teachers who are free at that time were also requested to attend the seminar. The meeting came to an end at 4.30 pm with an informal note of gratitude.
